This is to give you notice that HomeServices of Nebraska, Inc. doing business as Woods Bros Realty (“Woods Bros Realty”), HomeServices Relocation, LLC, HomeServices Lending, LLC, Capitol Title Company doing business as HomeServices Title (“HomeServices Title”), Wahoo Title, LLC doing business as HomeServices Title – Wahoo (“HomeServices Title - Wahoo”), and HomeServices of Nebraska Insurance, LLC are part of a family of companies (the “Affiliated Companies”), and each may refer to you the services of another.
